1. Key Terms

Videocoachme provides an online venue for language learning where Members, both Coaching clients and Coaches (terms defined below), can collaborate with each other and take advantage of the services (collectively, the "Services"). These Services are accessible at www.Videocoachme.com and any other websites where Videocoachme makes the Services available (collectively, the "Site"), and applications for mobile, tablet, and other smart devices and application program interfaces (collectively, the "Application").

If you are using the Site, Application or Services, these Terms of Service are between you and Videocoachme HK Limited (Videocoachme HK Limited is hereinafter referred to as "Videocoachme", "we", "us", or "our"). Videocoachme HK Limited will handle any and all payments and payouts conducted through or in connection with the Site, Application or Services ("**Payment Services**"). Payment Services provided by Videocoachme HK Limited are subject to the Payments Terms of Service ("**Payments Terms**").

"**Content**" means all Content that Videocoachme makes available through the Site, Application, Services, or its related promotional campaigns and official social media channels, including any Content licensed from a third party, but excluding Member Content.

"**Member Account**" means the Videocoachme Account you open when you register to become a Member and use the Services.

"**Member**" means a person or legal entity that registers for an Account.

"**Member Content**" means all Content that a Member posts, uploads, publishes, submits, transmits, or includes in their Member profile or Videocoachme promotional campaign to be made available through the Site, Application or Services.

"**Services**" means any of the Connection or Payment Services that are delivered by Videocoachme.

"**Coaching client**" means a Member that purchases Teaching Services.

"**Coach**" means a Member that offers and delivers Teaching Services.

"**Teaching Services**" means all Services delivered by Coaches. These include paid lessons, packages and other services rendered where Videocoachme Credits are exchanged.

"**User**" means (1) a person who is a Member, using the Site or Application on his or her own behalf, or (2) a person who is using the Site or Application on behalf of a Member that is a company or organization.

"**Visitor**" means a person who is only visiting the Site or Application, not a Member or User.

"**You**" means a Visitor or Member accessing the Site or Application or using the Services on his or her own behalf; or, if the Services are used on behalf of a company or organization, "you" means the Member for which the Services are used and the User who accesses the Site or

Application on behalf of such Member (and such User represents that he or she has the authority to do so on the Member's behalf).

2. Terms of Service

By using the Site, Application or Services, you agree to comply with and be legally bound by the terms and conditions of these Terms of Service ("Terms"), whether or not you become a registered user of the Services. These Terms govern your access to and use of the Site, Application and Services and all Content (defined below), and your participation in the Referral Program (defined below), and constitute a binding legal agreement between you and Videocoachme. In addition, certain areas of the Site and Application (and your access to or use of certain aspects of the Services or Content) may have different terms and conditions, standards, guidelines, or policies posted or may require you to agree with and accept additional terms and conditions. If there is a conflict between these Terms and terms and conditions posted for a specific area of the Site, Application, Services, or Content, the latter terms and conditions will take precedence with respect to your use of or access to that area of the Site, Application, Services, or Content.

If you do not agree to these Terms, you have no right to obtain information from or otherwise continue using the Site, Application or Services. Failure to use the Site, Application or Services in accordance with these Terms may subject you to civil and criminal penalties.

THE SITE, APPLICATION AND SERVICES COMPRISE AN ONLINE VENUE FOR LANGUAGE LEARNING WHERE MEMBERS, BOTH COACHING CLIENTS AND COACHS HOSTS MAY TAKE ADVANTAGE OF CONNECTION SERVICES AND PAYMENT SERVICES DIRECTLY WITH EACH OTHER. YOU UNDERSTAND AND AGREE THAT VIDEOCOACHME IS NOT A PARTY TO ANY AGREEMENTS ENTERED INTO BETWEEN COACHING CLIENTS AND COACHS OR BETWEEN MEMBERS, NOR IS VIDEOCOACHME A LANGUAGE SERVICES BROKER OR AGENT. VIDEOCOACHME HAS NO CONTROL OVER THE CONDUCT OF COACHING CLIENTS, COACHS, MEMBERS AND OTHER USERS OF THE SITE, APPLICATION AND SERVICES OR ANY SERVICES RENDERED BETWEEN THEM, AND DISCLAIMS ALL LIABILITY IN THIS REGARD TO THE MAXIMUM EXTENT PERMITTED BY LAW.

IF YOU CHOOSE TO TEACH ON VIDEOCOACHME, YOU UNDERSTAND AND AGREE THAT YOUR RELATIONSHIP WITH VIDEOCOACHME IS LIMITED TO BEING A MEMBER AND AN INDEPENDENT, THIRD-PARTY CONTRACTOR, AND NOT AN EMPLOYEE, AGENT, JOINT VENTURER OR PARTNER OF VIDEOCOACHME FOR ANY REASON, AND YOU ACT EXCLUSIVELY ON YOUR OWN BEHALF AND FOR YOUR OWN BENEFIT, AND NOT ON BEHALF OF OR FOR THE BENEFIT OF VIDEOCOACHME. VIDEOCOACHME DOES NOT CONTROL, AND HAS NO RIGHT TO CONTROL, YOUR LISTING, YOUR ACTIVITIES ASSOCIATED WITH YOUR PROFILE OR LISTED SERVICES, OR ANY OTHER MATTERS RELATED TO ANY SERVICES THAT YOU PROVIDE. AS A MEMBER YOU AGREE NOT TO DO ANYTHING TO CREATE A FALSE IMPRESSION THAT YOU ARE ENDORSED BY, PARTNERING WITH, OR ACTING ON BEHALF OF OR FOR THE BENEFIT OF VIDEOCOACHME,

INCLUDING BY INAPPROPRIATELY USING ANY VIDEOCOACHME INTELLECTUAL PROPERTY.

YOU ACKNOWLEDGE AND AGREE THAT, BY ACCESSING OR USING THE SITE, APPLICATION OR SERVICES OR BY DOWNLOADING OR POSTING ANY CONTENT FROM OR ON THE SITE, VIA THE APPLICATION OR THROUGH THE SERVICES, YOU ARE INDICATING THAT YOU HAVE READ, AND THAT YOU UNDERSTAND AND AGREE TO BE BOUND BY THESE TERMS AND RECEIVE OUR SERVICES WHETHER OR NOT YOU HAVE REGISTERED WITH THE SITE AND APPLICATION. IF YOU DO NOT AGREE TO THESE TERMS, THEN YOU HAVE NO RIGHT TO ACCESS OR USE THE SITE, APPLICATION, SERVICES, OR CONTENT.

If you accept or agree to these Terms on behalf of a company or other legal entity, you represent and warrant that you have the authority to bind that company or other legal entity to these Terms and, in such event, "you" and "your" will refer and apply to that company or other legal entity.

3. Modification

Videocoachme reserves the right, at its sole discretion, to modify the Site, Application or Services or to modify these Terms, including the Service Fees, at any time and without prior notice. If we modify these Terms, we will either post the modification on the Site or the Application or otherwise provide you with notice of the modification. We will also update the "Last Updated" date at the top of these Terms. By continuing to access or use the Site, Application or Services after we have posted a modification on the Site or via the Application or have provided you with notice of a modification, you are indicating that you agree to be bound by the modified Terms. If the modified Terms are not acceptable to you, your only recourse is to cease using the Site, Application and Services.

4. Eligibility

The Site, Application and Services are intended solely for persons who are 18 or older. Any access to or use of the Site, Application or Services by anyone under 18 is expressly prohibited. By accessing or using the Site, Application or Services you represent and warrant that you are 18 or older.

For users in the United States, Videocoachme may, to the extent permitted by applicable laws and if we have sufficient information to identify a user, obtain reports from public records of criminal convictions or sex offender registrations of the user. For users outside the United States, we may, to the extent permitted by applicable laws and if we have sufficient information to identify a user, obtain the local version of background or registered sex offender checks in our sole discretion. You agree and authorize us to use your personal information, such as your full name and date of birth, to obtain such reports, including from Videocoachme's vendors.

5. How the Site, Application and Services Work

The Site, Application and Services can be used to provide an online venue where Members, Coaching clients and Coachs, can collaborate with each other and take advantage of Connection Services and Payment Services for language learning.

Connection Services. The Site or Application is a venue where:

1. Members may upload information related to language learning.
2. Members conduct searches, connect with, choose, and engage each other for the purposes of language learning.
3. Coaching clients conduct searches, connect with, choose, and engage Coachs directly for language instruction.
4. Coachs advertise their capabilities, respond to inquiries, connect with and engage to provide their Services directly to Coaching clients.

In providing the Connection Services, Videocoachme only provides the venue for Coaching clients and Coachs to find and contract with each other.

Payment Services. The Site or Application is a platform for Coaching clients seeking online languages lessons or other language learning services to connect with Coachs seeking to provide online language lessons and other language learning services.

Payment Services also provide to Coaching clients and Coachs certain collaboration, feedback, credit purchase and payment tools, dispute resolution process and dispute assistance, and other Services (collectively, "Payment Services"). Payment Services does not mean Connection Services.

You agree to Videocoachme's Payment Terms of Service at www.Videocoachme.com/paymentterms.

Coach Services. Coach services are described in more detail on the Coach Terms of Service.

If you are accepted to be a Coach, you agree to Videocoachme's Coach Terms of Service at www.Videocoachme.com/instructorterms.

Unless explicitly specified otherwise in the Videocoachme platform, Videocoachme's responsibilities are limited to facilitating the availability of the Site, Application and Services.

6. Account Registration

In order to access certain features of the Site and Application, and to participate in language learning Connection Services and Payment Services on Videocoachme, you must register to create an account ("Videocoachme Account") and become a Member. You may register to join directly via the Site or Application or as described in this section.

You can also register to join by logging into your account with certain third-party social networking sites ("SNS") (including, but not limited to, Facebook; each such account is a "Third-

Party Account"), via our Site or Application, as described below. As part of the functionality of the Site, Application and Services, you may link your Videocoachme Account with Third-Party Accounts, by either: (i) providing your Third-Party Account login information to Videocoachme through the Site, Services or Application; or (ii) allowing Videocoachme to access your Third-Party Account, as permitted under the applicable terms and conditions that govern your use of each Third-Party Account. You represent that you are entitled to disclose your Third-Party Account login information to Videocoachme and/or grant Videocoachme access to your Third-Party Account (including, but not limited to, for use for the purposes described herein), without breach by you of any of the terms and conditions that govern your use of the applicable Third-Party Account and without obligating Videocoachme to pay any fees or making Videocoachme subject to any usage limitations imposed by such third-party service providers. By granting Videocoachme access to any Third-Party Accounts, you understand that Videocoachme will access, make available and store (if applicable) any Content that you have provided to and stored in your Third-Party Account ("SNS Content") so that it is available on and through the Site, Services and Application via your Videocoachme Account and Videocoachme Account profile page. Unless otherwise specified in these Terms, all SNS Content, if any, will be considered to be Member Content for all purposes of these Terms.

Depending on the Third-Party Accounts you choose and subject to the privacy settings that you have set in such Third-Party Accounts, personally identifiable information that you post to your Third-Party Accounts will be available on and through your Videocoachme Account on the Site, Services and Application. Please note that if a Third-Party Account or associated service becomes unavailable or Videocoachme's access to such Third-Party Account is terminated by the third-party service provider, then SNS Content will no longer be available on and through the Site, Services and Application. You have the ability to disable the connection between your Videocoachme Account and your Third-Party Accounts, at any time, by accessing the "Settings" section of the Site and Application.

PLEASE NOTE THAT YOUR RELATIONSHIP WITH THE THIRD-PARTY SERVICE PROVIDERS ASSOCIATED WITH YOUR THIRD-PARTY ACCOUNTS IS GOVERNED SOLELY BY YOUR AGREEMENT(S) WITH SUCH THIRD-PARTY SERVICE PROVIDERS. Videocoachme makes no effort to review any SNS Content for any purpose, including but not limited to for accuracy, legality or non-infringement and Videocoachme is not responsible for any SNS Content.

Your Videocoachme Account and your Videocoachme Account profile page will be created for your use of the Site and Application based upon the personal information you provide to us or that we obtain via an SNS as described above. You may not have more than one (1) active Videocoachme Account. You agree to provide accurate, current and complete information during the registration process and to update such information to keep it accurate, current and complete. Videocoachme reserves the right to suspend or terminate your Videocoachme Account and your access to the Site, Application and Services if you create more than one (1) Videocoachme Account, or if any information provided during the registration process or thereafter proves to be inaccurate, fraudulent, not current, incomplete, or otherwise in violation of these Terms of Service.

You are responsible for safeguarding your password. You agree that you will not disclose your password to any third party and that you will take sole responsibility for any activities or actions under your Videocoachme Account, whether or not you have authorized such activities or actions. You will immediately notify Videocoachme of any unauthorized use of your Videocoachme Account.

7. General Member Terms

Our Services are available only to legal entities and individuals in business who can form legally binding contracts. To register for an Account with Videocoachme and become a Member, you must accept all of the terms and conditions in, and linked to, the Terms of Service. Videocoachme reserves the right in its sole discretion to refuse, suspend, or terminate service to anyone.

It is the sole responsibility of each registered Member that all personal details, including contact email addresses are up to date and accurate at all times. By accepting these terms and conditions all Members hereby release Videocoachme from any claims, demands and damages (actual and consequential) of every kind and nature, known and unknown, suspected and unsuspected, disclosed and undisclosed, which arise due to inaccurate personal information being held on the site or application. All Members are solely responsible for the content and accuracy of any information published by them on Videocoachme.

Videocoachme reserve the right to suspend or terminate the membership of any registered Member for any reason. No refunds, payments or compensation of any kind will be paid to Members whose registration has been terminated due to breach of these terms and conditions.

8. Privacy

You agree to Videocoachme's Privacy Policy - www.Videocoachme.com/privacy.

9. Intellectual Property

Videocoachme and its licensors retain all of its right, title and interest in and to all patent rights, inventions, copyrights, know-how and trade secrets relating to the Site or Application. The Videocoachme logo and name are trademarks of Videocoachme, and may be registered in certain jurisdictions. All other product names, company names, marks, logos and symbols on the Site or Application may be the trademarks of their respective owners.

You agree to Videocoachme's Copyright Policy - www.Videocoachme.com/copyrightpolicy.

10. Site and Application License

Subject to and conditioned on compliance with the Terms of Service, Videocoachme grants you a limited license to access and, if you are a Member, to use this Site or Application internally for the purpose of ordering and receiving the Services available and authorized from this Site or Application. You must not sell, reproduce, distribute, modify, display, publicly perform, prepare

derivative works based on, repost or otherwise use any content of this Site or Application in any way for any public or commercial purpose without prior written consent of Videocoachme or the rights holder, unless such actions have previously been expressly permitted by Videocoachme or the rights holder for the content in question. You will not attempt to reverse engineer or attempt to interfere with the operation of any part of this Site or Application unless expressly permitted by law. You will not use, copy, adapt, modify, prepare derivative works based upon, distribute, license, sell, transfer, publicly display, publicly perform, transmit, broadcast or otherwise exploit the Site, Application, Services, or Content, except as expressly permitted in these Terms. No licenses or rights are granted to you by implication or otherwise under any intellectual property rights owned or controlled by Videocoachme or its licensors, except for the licenses and rights expressly granted in these Terms.

12. Member Content

We may, in our sole discretion, permit you to post, upload, publish, submit or transmit Member Content. By making available any Member Content on or through the Site, Application, Services, or through Videocoachme promotional campaigns, you hereby grant to Videocoachme a worldwide, irrevocable, perpetual (or for the term of the protection), non-exclusive, transferable, royalty-free license, with the right to sublicense, to use, view, copy, adapt, modify, distribute, license, sell, transfer, publicly display, publicly perform, transmit, stream, broadcast, access, view, and otherwise exploit such Member Content on, through, by means of or to promote or market the Site, Application and Services. 14. Enforcement of Terms of Service

We may suspend or cancel your Member Account if we believe that you have violated or acted inconsistently with the letter or spirit of the Terms of Service, or violated our rights or those of another party. Without limiting Videocoachme's other remedies, we will suspend or terminate your Member Account and refuse to provide any Services to you if: (a) you breach any terms and conditions of the Terms of Service and the other written policies and procedures posted on the Site or Application; (b) we are unable to verify or authenticate any information you provide to us; or (c) we believe that your actions may cause legal liability for you, our Users or for Videocoachme.

Once suspended or terminated, you may not continue to use the Videocoachme service under a different Account or re-register under a new Account. This includes usage of any associated Payment Services. In addition, violations of the Terms of Service may be prosecuted to the fullest extent of the law and may result in additional penalties and sanctions. If a User or Member engages in actions or activities which circumvent the Site or Application or otherwise reduces service fees owed Videocoachme under the Terms of Service, that User or Member will be liable to Videocoachme for the service fees due, and may be subject to additional sanctions including, but not limited to, suspension or termination of Videocoachme membership. IN NO EVENT SHALL WE OR OUR LICENSORS OR COACHS BE LIABLE TO YOU OR ANY OTHER MEMBER FOR ANY SPECIAL, INDIRECT, CONSEQUENTIAL, INCIDENTAL OR PUNITIVE DAMAGES PURSUANT TO THIS AGREEMENT, INCLUDING BUT NOT LIMITED TO, LOSS OF PROFITS, LOSS OF BUSINESS OPPORTUNITIES OR LOSS OF GOODWILL, EVEN IF ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.

NOTWITHSTANDING ANY OTHER PROVISION OF THIS AGREEMENT, IN NO EVENT WILL OUR LIABILITY TO YOU FOR ANY ACTION OR CLAIM RELATED TO THE SERVICES PROVIDED UNDER THIS AGREEMENT, WHETHER BASED ON CONTRACT, TORT, NEGLIGENCE OR ANY OTHER THEORY OF LIABILITY, EXCEED IN THE GREATER OF: (A) \$100 OR (B) THE AGGREGATE AMOUNT OF SERVICE CHARGES ACTUALLY COLLECTED BY US FROM YOU FOR THE SERVICES TO WHICH THE LIABILITY RELATES DURING THE SIX (6) MONTH PERIOD IMMEDIATELY PRECEDING THE DETERMINATION OF SUCH LIABILITY. failure to pay any invoice or any other payment; and/or (x) your obligations as a Coach or to a Coach. Any such indemnification shall be conditioned on our: (a) notifying you in writing of any such claim, demand, action, cost, liability, loss or threat of any thereof; (b) cooperating with you in the defense or settlement thereof; and (c) allowing you to control such defense or settlement. We shall be entitled to participate in such defense through our own counsel at our own cost and expense. We reserve the right to report any wrongdoing of which we become aware to the applicable government agencies or otherwise.

18. Accessing and Downloading the Application from iTunes

The following applies to any Application accessed through or downloaded from the Apple App Store ("App Store Sourced Application"):

23. Controlling Law and Jurisdiction

The Terms of Service are governed in all respects by the laws of Hong Kong without giving effect to any principle that may provide for the application of the law of another jurisdiction. You agree that any claim or dispute you may have against Videocoachme must be resolved by a court located in Hong Kong, or as described in the Arbitration Option paragraph below. You hereby submit to the personal jurisdiction of the courts located within Hong Kong for the purpose of litigating all such claims or disputes. Any cause of action you may have with respect to this Site or Application must be commenced within 30 days after it arises, or the cause of action is barred.

24. Dispute Resolution

If a dispute arises between you and Videocoachme, our goal is to resolve such dispute quickly and cost effectively. Accordingly, you and Videocoachme agree that we will resolve any claim or controversy at law or equity that arises between us out of this Agreement or the Videocoachme Services (a "**Claim**") in accordance with this section entitled "Dispute Resolution." Arbitration Option

agreed by the parties; and (c) if an arbitrator renders an award the party receiving the award may enter any judgment on the award in any court of competent jurisdiction.

Improperly Filed Claims

Should you file a claim contrary to this section entitled "**Dispute Resolution**," Videocoachme will be entitled to recover attorneys' fees and costs up to HKD 10,000, provided that Videocoachme has notified you in accordance with the Terms of Service of the improperly filed claim, and you have failed to promptly withdraw the claim.

25. General

The failure of Videocoachme to enforce any right or provision of these Terms will not constitute a waiver of future enforcement of that right or provision. The waiver of any such right or provision will be effective only if in writing and signed by a duly authorized representative of Videocoachme. If for any reason an arbitrator or a court of competent jurisdiction finds any provision of these Terms invalid or unenforceable, that provision will be enforced to the maximum extent permissible and the other provisions of these Terms will remain in full force and effect.
